

Terms & Conditions															
1	The work is to be carried out at New Port Colony & CISF Complex at New Kandla.														
2	The work shall be completed within Two Months after issue of work order or clear site of work is given.														
3	The quotationer are expected to have full knowledge of the site of work & local working condition before submitting the quotation and no claim whatsoever will be entertained of any nature of work, arising out to the local condition of site.														
4	The quotationer shall be required to execute the work in such a way so as not to cause any damage / hindrance with the activity going on in near by area.														
5	All the rules & regulation governing D.P.A. will be applicable.														
6	Whenever & whichever machineries, tools or equipment's are to be arranged by quotationer along with fuel charges.														
7	Income-tax and surcharge as applicable shall be made while making payment to the quotationer for carrying out the work & only net amount shall be paid as directed by the Central Board of Direct Taxes, Ministry of Finance, Government of India.														
8	After completion of work the site should be neatly cleaned by the Quotationer.														
9	Force Majeure: This will be restricted to natural calamities and acts of GOD only.														
10	All the material shall required for the work shall be got approved from Engineer in-charge before put into use.														
11	On successful completion of work after issuance of completion certificate, 90% payment will be released and 10% amount of bill will be withheld against Security Deposit.														
12	EMD of successful bidder will be released after completion of work and issuance of completion certificate.														
13	Superintending Engineer (R) reserves the right to cancel the quotation without assigning any reasons and also increase/ decrease the														
14	The rates to be quoted excluding GST. However, GST element will not be considered for evaluation of bid price.														
15	10% payment will be released on successful completion of defect liability period as certified by Engineer in-charge.														
16	The contractor shall not deposit any materials at such a place, that may cause inconvenience to the public or staff or near by offices.														
17	For the purpose of measurement the method prescribed in standard code of measurement of the concern work shall be applicable.														
18	If applicable, All tools, plants, scaffolding ladder etc. and other machinery etc. required temporary for the purpose of execution of work will have to be arranged by the contractor at his own cost and storing of such tools, plants etc. will have to be made by him.														
19	The Contractor shall ensure not to cause any damage to the port properties in the vicinity of work site during execution of work. If any damage occurs due to workmen / machinery of the contractor, the contractor has to make good the loss / damage at his cost.														
20	GST CLAUSE:														
(i)	The contractor shall quote the price exclusive of GST. The contractor shall quote prevailing GST rate separately which shall be reimbursed by DPA after ascertaining necessary compliance as per Goods & Service Tax – 2017. The contractor should have valid GST registration number to become eligible for Participating in the bid. However, GST will not be considered for evaluation of bid Price. All other duties, taxes, cesses applicable if any, shall be borne by the contractor.														
(ii)	GST Registration No. shall have to furnish by Quotationer, failing which the Bid/Quotation will be considered as non-respective and be liable for discharge.														
(iii)	GST & PAN No. may be furnished with documentary evidence along with the Tender Documents.														
(iv)	The TDS under GST Act is required to be deducted @ 2% (1% CGST and 1% SGST or 2% IGST) from payment / credit given to contractors /professionals and others for work order/contracts exceeding Rs. 2,50,000.00														
(v)	Contractor / Service provider / supplier etc. has to ensure timely and proper filling of GSTR 1 so that Deendayal Port Authority can avail input tax credit in timely manner. In case DPA not allowed input tax credit due to failure on part of the contractor / service provider/ supplier etc., it will be a financial loss to the DPA and therefore same shall be recovered from the payment / deposit of the contractor /

23	The defect liability period / Guarantee Period) for the subject work is of Six Months from the date of completion of work as certified by Engineer-in-charge														
	a) Contractor is responsible for rectify defects of relevant items carried out in work, during defect liability period and no any payment for that will be made to contractor for that, in defect liability period.														
	b) The contractor shall be responsible to make good and remedy at his own expenses any defect which may be develop or may be noticed before the period mentioned hereunder from the certified date of completion. The Engineer in charge shall give the contractor a notice in writing above the defects and the contractor shall make good the same within 15 days of receipt of the notice. In the case of failure on the part of the contractor, the Engineer in charge may rectify or remove or re-execute the work at the risk and cost of contractor.														
	c) If contractor fail to attend the defect if any, within 15 days of written notice served by the Engineer in charge, during Defect liability period, the Security Deposit will be forfeited, and defect will be rectified on risk and cost of contractor.														
24	Liquidated damages shall be levied at the rate of 0.50% of part thereof (per week / part thereof) of contract value for delay of each week of part thereof subject to maximum of 10% of contract value in the event of failure to complete the work in the stipulated period of completion or such extension as may be granted.														
25	The Bidder should have experience of "Building Work". If bidder completed the works in private organization, then TDS certificates with respect to referred work needs to be submitted. Failure to provide these TDS documents will result as non-responsive of bid.
